

INVITATION FOR BIDS

Sealed bids, subject to the conditions contained herein, will be received by The Board of Water and Sewer Commissioners of the City of Mobile, Alabama, at their 207 North Catherine Street offices until 1:15 p. m., Local Time, (DATE) and then publicly opened and read for furnishing all labor and materials and performing all work for constructing, Contract No. (#), (PROJECT NAME). The work consists principally of the following approximate quantities:

Plans and specifications may be inspected at the offices of The Board of Water and Sewer Commissioners of the City of Mobile, Alabama, 207 North Catherine Street, Mobile, Alabama, or at the offices of (CONSULTING ENGINEER), Consulting Engineers, (ADDRESS), Mobile, Alabama, or at the ABC/ Dodge Plan Room, 755 C McRae Avenue, Mobile, Alabama.

Copies of the plans and specifications may be obtained from (CONSULTING ENGINEER), (ADDRESS), upon payment of a charge of \$ (\$) for each set to (CONSULTING ENGINEER), to cover the cost of printing, reproduction, handling, and distribution and will not be refunded. No plans and specifications will be issued to contractors later than twenty-four (24) hours prior to the time indicated above for receiving bids.

Guarantee will be required with each bid for at least 5% of the amount of bid not to exceed \$10,000 filed in the form of a certified check, bid bond, or irrevocable Letter of Credit acceptable to the Owner payable to The Board of Water & Sewer Commissioners of the City of Mobile, Alabama. Bid Bonds shall include certification that the bonding company is listed in Circular 570 of the U. S. Treasury Department. The name, address, telephone number, and contact person for the bonding company shall also be included.

The Contractor shall furnish either a "Contract Bond" and a "Labor and Material Bond" or an irrevocable "Letter of Credit" acceptable to the Owner. All bonds and letters of credit shall be for 100% of the contract price.

Bids must be submitted upon the standard forms furnished by The Board of Water and Sewer Commissioners of the City of Mobile, Alabama, included in the Project Specifications.

The right is reserved, as the interest of the Owner may require, to reject any and all bids and to waive any informalities in bids received. Failure to complete and sign the Proposed Subcontracting Plan in the Proposal shall be cause for rejection of bid. In the event that no subcontractors will be used, the form shall read zero and shall be signed.

The Board of Water and Sewer Commissioners of the City of Mobile has entered into a Consent Decree (Exhibit 1) with the United States Department of Justice, Environmental Protection Agency, the State of Alabama and Mobile Bay Watch, Inc. The Consent Decree applies to, and is binding upon the United States on behalf of the Environmental Protection Agency, and upon the State of Alabama, Mobile Bay Watch, Inc. and the Board of Water and Sewer Commissioners of the City of Mobile, Alabama and their officials, officers, directors, employees, agents, servants, successors and assigns, and upon all persons, firms and corporations who assist the

Board in performing its obligations under this Consent Decree. All contractors, subcontractors, vendors, and others hired to perform work pursuant to the Consent Decree must comply with the terms of the Consent Decree and with all applicable law.

Failure to complete the “Contractor Consent Decree Notification” in the proposal will be cause for rejection of bid.

Envelope containing bids must be sealed, marked, addressed as follows, and delivered to the Director, Board of Water and Sewer Commissioners of the City of Mobile, Alabama, 207 N. Catherine Street, Mobile, Alabama 36604: Bid for Constructing, Contract No. (#), (PROJECT NAME), to be opened 1:15 p. m., Local Time, (DATE). The Bidder’s Alabama State Contractor’s License Number and discipline shall be included on the envelope containing the submitted proposal.

Attention of Bidders is called to the license required by Title 34, Chapter 8, of the Code of Alabama, 1975, and amendments thereto, relating to the licensing of General Contractors. Only bids from qualified contractors licensed as required by the Alabama State Licensing Board for General Contractors will be accepted.
