 - "WL-1 20" Ductile Iron Water Main Line Pipe (Restrained Joint) (Zinc Coated Carrier Pipe), Class 250, Open Cut Installation: The unit price bid for this pay item shall be compensation in full for furnishing all material, labor, equipment, and incidentals (including restrained joints with Fast Grip Gaskets or approved equal) necessary to install one (1) linear foot (LF) of Ductile Iron Class 250 pipe complete in place and in accordance with the plans and standard specifications. The exterior of all ductile iron pipe installed shall be zinc coated. Measurement for payment will be made along the centerline of installed pipe, such measurement starting at the centerline of installed pipe and terminating at the centerline of junctions or to the various ends. There will be no deductions in measured length for specials, fittings, or valves installed in the line."

2. Revise Special Provisions Section 10.43 – Basis of Payment for Base Bid, delete pay item WL-1A in its entirety an replace with the following:

"WL-1A 20" Ductile Iron Water Main Line Pipe (Restrained Joint) (Zinc Coated Carrier Pipe), Class 350, Installation Auger Bore Installation: The unit price bid for this pay item shall be compensation in full for furnishing all material, labor, equipment, and incidentals (including restrained joints with Fast Grip Gaskets or approved equal) necessary to install one (1) linear foot (LF) of Ductile Iron Class 350 carrier pipe within the auger bore steel casing, complete in place and in accordance with the plans and standard specifications. The steel encasement pipe installed by auger bore will be paid for under a separate pay item. The exterior of all installed ductile iron pipe shall be zinc coated. Measurement for payment will be made along the centerline of installed pipe, such measurement starting at the centerline of installed pipe and terminating at the centerline of junctions or to the various ends. There will be no deductions in measured length for specials, fittings, or valves installed in the line."
