The Board of Water and Sewer Commissioners of the City of Mobile met this Monday in their regular session at 1:30 p.m. at MAWSS' Park Forest Plaza.

Commissioner Bell called the meeting to order and gave the invocation.

**Committee Reports** were next; Commissioner Drummond summarized the **Growth and Development** / **Infrastructure** / **Property Committee Meeting** held this morning at 11:00 a.m. The committee reviewed in depth the following topics: Springhill Reservoir Property Sale, Consulting Engineering Services Contract, Model Utility Document, South of Laurendine Road Assets, MCWSFA Inner-Connections, Easement/Property Acquisitions for Eslava Creek Trunk Relief Sewer Project, Brucewood Drive Fire Protection, Land for Sale in the Big Creek Lake area, and the proposed (Forestry) Land Management Contract.

**Visitors** were in attendance. Mr. McCrory extended warm wishes and congratulations to **MR. JODY P. CALHOUN**, Treatment Plant Operator I, on his retirement after 13 years of service and **MR. NORMAN C. ROLLO**, Water Service Construction Inspector, on his retirement after 22 years of service.

- Meter Replacement at Mobile Infirmary Hospital (10")
- New Sensus 10" AMI Meter
- Meters encased in concrete (slows replacement)
- Residential meters that have become entwined in tree roots (slows replacement)

### Minutes of the meeting of the Board November 13, 2023

### Item 6A C.E.R.M. Project No. 2022-1438A-003A MAWSS Waterline Replacement – Multiple Locations

The engineers estimate for this project is \$955,034.40; there were two bidders, and the apparent low bidder was G H, LLC in the amount of \$755,165. Staff will bring this item back to the Board at a later date.

### Item 6B McCrory & Williams Project No. M5712-2774 Dr. MLK Jr. Avenue Sewer Repair

The engineers estimate for this project is \$340,000; there were two bidders and the apparent low bidder was Hughes Companies, Inc. in the amount of \$302,250. Staff will bring this item back to the Board at a later date.

### Item 6C McCrory & Williams Project No. M5712-2775 2024 Annual Contract for Cured-In-Place Pipe Rehabilitation of Large Diameter Sanitary Sewer Mains

The engineers estimate for this project is \$2,300,000; there were six bidders and the apparent low bidder was BLD Services, LLC in the amount of \$5,083,880. Staff will bring this item back to the Board at a later date.

#### Item 6D McCrory & Williams Project No. M5712-2780 2024 Annual Contract for Access Roads Construction and Sewer Easement Maintenance

The engineers estimate for this project is \$1,000,000; there were three bidders and the apparent low bidder was James H. Adams & Son Construction Co., Inc. in the amount of \$1,224,444. Staff will bring this item back to the Board at a later date.

### Item 6E McCrory & Williams Project No. M5712-2783 2024 Annual Contract for Cleaning & Video Inspection of Various Sanitary Sewer Segments (Small Diameter)

The engineers estimate for this project is \$1,000,000 there were three bidders and the apparent low bidder was Smith Industrial Services in the amount of \$1,150,000. Staff will bring this item back to the Board at a later date.
